ONLINE PRIVACY POLICY AGREEMENT

Why We Collect Information and For How Long

Use of Information Collected

C.H.R.I.S.T. Ministry does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

C.H.R.I.S.T. Ministry may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from CHRISTMinistryTogether.org

C.H.R.I.S.T. Ministry may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

C.H.R.I.S.T. Disclosure of Information

- as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of C.H.R.I.S.T. Ministry.

Non-Marketing Purposes

C.H.R.I.S.T. Ministry greatly respects your privacy. We do maintain and reserve the right to contact you if needed for non-marketing purposes (such as bug alerts, security breaches, account issues, and/or changes in C.H.R.I.S.T. Children under the age of 13

Notice to European Union Users

C.H.R.I.S.T. Ministry's operations are located primarily in the United States.
